

Terms and Conditions

Every effort has been made to ensure that the information contained in this Prospectus is correct at the time of going to press. The School will use reasonable endeavours to deliver programmes and other services in accordance with the descriptions provided.

The School, however, reserves the right to make variations to programme contents, entry requirements and methods of delivery, and to discontinue, merge or combine programmes, both before and after a student's admission to the School, if such action is reasonably considered necessary by the School.

In the event that, prior to the student commencing the first term of study for any programme described in this Prospectus, the School discontinues the programme, the student may either (1) withdraw from the School without any liability for fees; or (2) transfer to such other programme (if any) as may be offered by the School for which the student is qualified. If in these circumstances the student wishes to withdraw from the School and to enrol in a course at a different University, the School shall use its reasonable endeavours to assist the student.

Once the student has commenced the first term of study, if:

(a) the School's ability to deliver programmes or other services in accordance with the descriptions provided is compromised by circumstances beyond the control of the School (e.g. third party industrial action), the School will use all reasonable endeavours to minimise disruption as far as it is practical to do so;

(b) the programme is cancelled or substantially varied from that described in the Prospectus for reasons other than circumstances beyond the School's reasonable control; the School will use reasonable endeavours to provide a suitable replacement programme. If the student does not wish to accept the replacement programme, the student shall be entitled to withdraw from the programme. In the event of such withdrawal the School shall make an appropriate refund of course fees.

Deposit Payments (Terms and Conditions)

Under the terms of your offer of admission, once a deposit is paid you have 14 days in which to change your mind and request a full refund. We will withdraw your offer and authorise a deposit refund if you notify us, in writing within this period that you no longer wish to take up your offer and complete the deposit refund request form.

After this time the deposit is non-refundable (except in circumstances where the School later rejects your application on the grounds that you have not met the entry requirements set out in your offer of admission).

You are strongly advised to ensure that you will have sufficient funds in place to fund your programme of study before accepting your offer, as deposits will not be refunded on grounds of financial hardship.

If the condition of your offer requires you to show evidence of your academic results you will need to show evidence that you meet the condition after paying the deposit and accepting the offer and the start of the programme.

If the condition of your offer requires you to achieve higher English scores, or provide evidence of English language, you must show that you sat a valid English exam or send acceptable evidence in between paying the deposit and accepting your offer and the start of the programme. If you do not retake an English test or show evidence in time for the start of the course you will not receive a refund.

Please note: Refunds will be made in full based on the value UK sterling at the time of repayment.

Our decision guarantee

Offer acceptance and enrolment at the School is subject to a 14 day cooling off period.

At offer acceptance stage changes can be made in during the 14 day period. Any requests for change after 14 days are not guaranteed and will require a written request. We aim to respond to requests within 14 working days.

Upon enrolment at the School withdrawal within the first 14 days following enrolment will not incur any financial penalty. Please note, that for students holding a Tier 4 student visa this will result in the appropriate withdrawal report to the UKVI and visa curtailment.
