

## Moderation Policy (Emergency Regulations 2022-23)

The TeLSEC sub-group formed to approve policies or appropriate in line with the emergency regulations agreed the amended moderation policy for 2022/23 outlined below.

Departments should aim to apply the standard moderation policy as described in the <u>Assessment Handbook</u> wherever possible. Where the disruption is such that the standard moderation policy cannot be applied, departments may alter the moderation requirements as outlined below to mitigate the impact of the disruption.

Where the amended moderation policy is applied, a record must be kept by the department (for each individual assessment item) and submitted to Registry by the marking deadline.

This policy is valid for assessment activities until the end of academic year 2022/23, including late summer resits.

In all modules, a minimum of 5 exam scripts should be moderated and all fails;	No change
Any <b>single</b> element exam weighted at <b>100%</b> should be double marked.	No change
Any element of assessment weighted 11- 99% that is first marked by a GTA must be moderated at least 15% and a minimum of 10 scripts	No change
