# 1 - As a student from another University of London college you can register as an intercollegiate student at SOAS only if:

- permission for you to attend a course at SOAS is given by the appropriate **academic** authority at your home College.
- permission for you to attend a course at SOAS is given by the appropriate administrative authority at your home College to confirm that they will pay the tuition fee. Your College must indicate your tuition fee status SOAS will assume and charge your College at the "Overseas" rate if no information is given. Fees are charged pro rata at the relevant standard SOAS undergraduate or Master's fees rate.

You may only attend courses you have been registered for. Continued attendance is conditional upon your satisfactory academic performance and compliance with the School's regulations
