

## PAUL DUNDAS: BIBLIOGRAPHY

John E. Cort

Paul Dundas (1952-2023) was one of the leading scholars of the Jains in recent decades. His scholarship also encompassed Prakrit language and literature, Sanskrit literature, and South Asian Buddhism. Presented here is a comprehensive list of his works - books, translations, articles, chapters in edited volumes, encyclopedia articles and entries and book reviews - as well as a list of reviews of his books. This bibliography of the publications of Paul Dundas (1952-2023) is based upon a curriculum vitae he prepared in 2022. It was not complete, so I have added some items that I know were missing from it. It may still be incomplete, but nothing major is missing.<sup>1</sup>
